Cervical Screening Research Findings

The full findings of the WI's research on attitudes towards cervical screening are now available to download in a series of short briefings from **[My WI and the WI website](#)**. Each briefing focuses on a different theme identified in the research: HPV self-sampling, strategies that can improve uptake of cervical screening, public awareness of the basic science behind cervical cancer, and barriers to attendance.

APPG on Microplastics: Policy Report Launch

On the 21st of September, the APPG on Microplastics will be launching its first policy report on cleaning up our microplastic problem in Parliament.



As Secretariat of the APPG on Microplastics, the NFWI Public Affairs team has worked with the office of Alberto Costa MP and over 30 stakeholders across the lifecycle of a garment to propose 6 holistic policies that would help to stem the tide of microplastic fibres emitted from clothing during the washing process.

This work has been done as part of the WI's 'End Plastic Soup' campaign, and will be open to MPs and Peers.
